m) To advance any other objects of general public utility.

The trust shall be an Irrevocable Public Educational Trust for the benefit of all persons belonging to whatever community irrespective of caste, creed or religion

4) UTILIZATION

A. The funds, income and property of the Trust will be applied solely for the promotion of the objects of the Trust, as set forth above and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise howsoever by way of profit to any person provided that nothing herein contained shall prevent the payment in good faith of remuneration of any officers or servants or employees of the Trust or other persons in return for any services rendered to the Trust.

B. The above named Trustees shall be first Trustees of this Trust.

5) NUMBER OF TRUSTEES

The number of Trustees shall be not less than 2 and not more than 7. The Trustees may co-opt others as Trustees. Any Trustee may resign by giving notice in writing to his co-trustees and any trustee shall also cease to be a trustee, if requested in writing by majority of the Trustees. Appointment of Trustees either to fill up vacancy or as additional trustee shall be by resolution of majority of the Trustees. However the Trustee S.Suresh Kumar shall be Trustee for life. In case of vacancy of a Trustee the other Trustees can co-opt a person.

6) VACANCIES

If any vacancy arises in the Board of Trustees on account of death, in capacity or persistent neglect of any Trustees or if a Trustee resigns his office or a Trustee be adjudged insolvent or if a trustee is found guilty of any criminal offence involving moral turpitude then such vacancy shall be filled up by the remaining Trustees by a majority vote. In the case of a tie the Managing Trustee of the Trust for the time being shall have a casting vote.

7) TERM OF OFFICE OF TRUSTEES

One third of the trustees shall retire every year and shall be eligible to be co-opted again by the other trustees who continue to hold the office.

8) QUORUM

Two Trustees shall form the quorum for Board of Trustees Meetings. Decision shall be taken by the vote of simple majority of the members present and voting.

- B. The Trustees shall be entitled to engage a whole time secretary and also such other staff as may be necessary for the management of the Trust.
- C. Proper books of account shall be kept with regard to all the expenses incurred by the Trust as well as the receipts of moneys including income realized by the Trust.
- D. Normally after defraying all necessary expenses incurred in the realization of the income of the Trust, the annual income may be spent by the Trustees for the various objects of the Trust. However, in the case of receipts on account of offerings, donations and other such income which is returned in the nature of income, the Trustees shall be at liberty to either utilize it for the objects of the Trust as per provisions of the Income Tax Act, 1961 as modified by Legislature from time to time.
- E. All proceedings of the Trustees with regard to the meetings and decisions shall be faithfully and correctly recorded in a proceedings book kept for the purpose. The said proceedings book shall remain in the custody of the Managing Trustee of the Trust.
- F. To identify, deal with, negotiate, purchase, and take on lease such lands, houses, tenements and immovable property generally as the Trustees may think fit or desirable for the establishment, promotion, running of educational institutions.
- G. To get the sale deed or lease deed executed and registered and to appear before the Sub-registrar, sign any document, deeds or such other papers in connection with the registration of the documents and to get the documents registered and to pay the consideration and get the receipt.
- H. To enter into any development with any developer or builder authorizing him to develop any of Trust properties as mentioned above and to do and execute all acts and deeds as may be required to be done or executed.
- I. The Trustees shall also be entitled to use the subject matter of the Trust or any part thereof for laying out, erecting and furnishing any building, research institute or for incurring any capital expenditure as may be resolved by majority of the Trustees.

- 10) Without prejudice to the generality of the powers vested in the Trustees and not withstanding anything contained in the Indian Trust Act, 1882, the Trustees shall have the following specific powers:

 - To open accounts with any Bank or Banks, to operate such accounts and to give instructions to the Bank and to provide for opening and operation of such accounts by two of the trustees.
 - To adjust, settle, compromise, compound, and refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust Properties or affairs.

- l) To acquire by Purchase, gift, grant, bequest, exchange, lease, hire or otherwise, properties of all kinds including movable and or immovable properties and to convert or reconvert one kind of property into any other kind, to improve and add to the corpus of the Trust and subject to the terms and conditions and covenants contained herein:

4. To borrow any money required for the purpose of trust upon such terms and upon such securities as may be determined by the settler and one of the trustee.

15) ACCOUNTS

1. The accounts of the trust shall be maintained regularly. The accounts shall be duly audited by the Chartered Accountant. Every year the accounts shall be closed on 31st March. 17) AMENDMENTS

- A. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of Trustees. In the absence of such regulations:
 - i) Majority will decide all matters and two trustees shall form a quorum for meeting of Trustees.
 - ii) Resolution passed without any meeting of the Trustees and evidenced in writing under the majority of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the Trustees.
- B. It is expressly declared that no part of the Trust property or its income shall be applied for any purpose other than the objects of the trust and nothing herein shall be construed to authorise the Trustees to utilize the trust assets or its income for any other purposes.
- C. Subject to the provisions of these present, the trustees shall have their authority and power from time to time to make, alter and rescind rules and regulations for management and administration of the affairs of the trust.


